Title 12                      Park & Recreation Regulations                      page 346

(10) **Motorized Vehicles.** Except for authorized maintenance vehicles, no person shall operate an unlicensed or licensed motorized vehicle outside of areas specifically designated as parking areas or areas where the operation of such vehicles is specifically permitted. Motor vehicles are restricted to the roads and drives and parking areas. No motor vehicles of any nature may be used on the seeded areas except vehicles which have a Common Council or Park Board authorization for shows, rides ~~or~~, exhibits **or programs.** **Unpaved parking areas for motor vehicles may be designated in Memorial Park for specific events by the Park Board, Common Council or their designee.** ~~and then only for the purpose of loading and unloading.~~ No person shall operate any off-the-road vehicle, motorcycle, trail bike, all-terrain vehicle, truck or other motorized vehicle in any park, playground or other public ground where pathways or trails have been developed and/or designated for walking, hiking, jogging, running, bicycling, cross-country skiing, sledding or other pedestrian use. All motorized vehicles are limited to use of roadways specifically for their use and according to other restrictions in this Code.
