1. Call to order.
2. Plow museum.
  - Review May 12, meeting with County re: plow museum matters.
3. Miner Park.
  - Abutting owners are okay with Historic Pioneers mural on east side and folk art on west. Hoover Const. plans to install both.
4. Rail Displays.
  - Still awaiting construction Proposal for Lake Ave. display building. Display items are ready.
5. Bike Paths.
  - Update, if any.
  - No response to letter to Town of Grant regarding marking trail over Gokey Road. This is intended to link Riverview Trail to the Flambeau Mine Trail.
  - Need to walk Riverview Trail with Dave Thompson before it greens up and bugs get bad. Owing to steep slopes, there will be challenges creating gentler bypasses requested by local bikers.
6. Farmer's Market.
  - Is there interest in proceeding with plans for farmer's market addition at all-new location? A cost estimate has been received. Rusk County Property Committee seemed somewhat icy to idea and suggested the fairgrounds. One of the primary reasons the City has supported the market has been to draw folks downtown, which a fairgrounds location likely wouldn't do.
7. Silhouettes.
  - Northern Machine had been approved to cut these out of 1/8" steel and has been asked to quote painting them with automotive paint. A different vendor will need to be found or go to wood-based signboard.
8. Veterans Mural.
  - Current plans are for Camp Flambeau to construct mural frames at the following locations: across Hwy. 8 from Memorial Park entrance; and along east side of parking lot west of Post Office.
9. Brooklyn Bridge Painting.
  - The (black satin) paint has been ordered and the vendor's Proposal approved.

10. Review status of full-sized covered bridge for Falge Park.
  - Permits needed if dredging is to be done. Costs to prepare and review permits have been quoted.
  - Need Council approval of fees for permit preparation.
  - A no dredge option is being investigated, as is use of culvert assistance.
11. Consider real elevated plow sign option for plow museum.
  - Need to find signpost.
  - Dave Bailey will prepare quote to fabricate post.
  - Concrete base quote needed. B. Parmley will design.
  - Thompson Exc. will donate erection of sign.
  - County Property Committee seemed to concur with idea, although ideas differ on exact placement.
12. Consider request to add half moon of decorative pavers in front of bench on east side of Miner Plaza, and to replace single bench with two. I would be cautious about the latter as original donor (Gold Star Mothers?) might be offended.
13. Murals.
  - Reactions to mural article in May, 2017 issue of The Municipality.
  - Consider suggestion of mural featuring image of fallen officer over backdrop of black and blue flag.
